9     information and offerings you need to lead a healthy lifestyle.”

11    Whereas, Cornell Dining is devoted to providing students with nutritional information and  
12    healthy food options.

14    Whereas, it is important to know the nutritional value of the food you are eating.  
15  
16    Whereas, Cornell Dining does not display pertinent nutritional information in dining halls.

18    Whereas, students are not able to make the healthiest dietary choices.  
19  
20    Whereas, students would be able to make healthier meal choices if nutritional information was  
21    displayed.

23    Be it therefore resolved, the SA recommends that Cornell Dining display pertinent nutritional  
24    information in the dining halls.

26    Be it therefore resolved, that Cornell Dining conveys information regarding its food in a similar  
27    manner as stipulated by the Nutritional Labeling and Education Act passed by the United  
28    States Congress in August of 1994.

30    Be it finally resolved, that a copy of this resolution be forwarded to the University Assembly  
31    Campus Welfare Committee.
